### 3. Handling and storage

- Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material.
- Keep container tightly closed. Keep container in a cool, well-ventilated area. Store at -20°C. Hygroscopic. Light sensitive.
