3. Handling and storage

- Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not breathe dust.
- Keep container tightly closed. Keep container in a cool, well-ventilated area. **Store at +2°C to +8°C. Protect from light.**

4. Exposure controls/Personal protection

- Use process enclosures, local exhaust ventilation, or other engineering controls to keep airborne levels below recommended exposure limits. If user operations generate dust, fume or mist, use ventilation to keep exposure to airborne contaminants below the exposure limit.
- Wash hands after handling compounds and before eating, smoking, using lavatory, and at the end of day.
